

Q1 To what extent do you agree that Non-Profit Organisations in Uganda have the following broad characteristics?







Q4 Where should the comparative financial information of an Non-Profit Organisation (NPO) be presented?







Q6 Do you agree that the terms "surplus and deficit" should be used by Non-Profit Organisations instead of "profit or loss"?





Q7 Do you agree that, in arriving at a surplus of deficit, Non-Profit Organisations should be able to choose whether to present either income or expense items first?




