The 2021 Financial Reporting (FiRe) Awards was held on 10 November 2021, from 10.00 am, at the Protea Hotel Kampala Skyz. The event was also broadcast live via the Zoom platform and social media. The theme was Integrated Reporting: Building Blocks for Stakeholder Confidence. 88 organisations submitted their annual reports for evaluation. The FiRe Awards is organised by the Institute of Certified Public Accountants of Uganda (ICPAU), in partnership with the Capital Markets Authority, the Uganda Securities Exchange and Vision Group. NSSF Wins Third Gold Award in Financial Reporting

The National Social Security Fund (NSSF) won the Gold Award at the 2021 Financial Reporting (FiRe) Awards. NSSF beat 87 organisations who submitted their annual reports for evaluation. According to the Chairman of the Financial Reporting Awards Committee, the NSSF report had a strong focus on strategy and value creation, and provided a clear explanation of the utilisation of the six capitals in the value creation process. **Read more ...**
