I commend you once again on your achievements and wish you the best of today's celebrations.




No. of ATD Graduands




ATD Graduands by Gender




No. of CTA Graduands




CTA Graduands by Gender

- Institute of Certified Public Accountants of Rwanda
- National Board of Accountants and Auditors of Tanzania
- Ordre des Professionnels Comptables du Burundi (OPC Burundi)

EACIAs members should have attempted and completed the CPA course-related exams in their mother bodies.



NOTE: Apart from fully recognised members from the EACIAs, other holders of Foreign Accountancy Qualification (FAQ) may be required to sit for all or some of the following:

- CPA 5 Business & Company Law
- CPA 13 Public Financial Management
- CPA 16 Audit Practice & Assurance
- CPA 17 Advanced Taxation

Exemption from CPA 5 Business & Company Law may be granted if it was covered during the first degree pursued in Uganda.

Applicants are required to submit the following:

- a) Printed, completed, and signed online application form
- b) Completed documentation of Practical Experience Training (PET) in the PET logbook
- c) Recommendation letters from:
 - i. Either current or former employer within the past three years, and;
 - ii. A full member of ICPAU in good standing, known to the applicant personally.
- d) Curriculum Vitae (CV)
- e) Original or certified copies of academic support documents; transcripts and certificates for O-level, A-level, diplomas, degrees and professional courses.
- f) Proof of payment of enrolment fees
- g) One (1) colour photograph (passport type with white background)


