### ICPAU NEWS AGM UPDATES



The 30<sup>th</sup> Annual General meeting (AGM) of the Institute of Certified Public Accountants of Uganda (ICPAU) was held on Thursday, 20 June 2024 at the Imperial Royale Hotel, and online to transact the following business:

- 1. To review the minutes of the 29<sup>th</sup> AGM.
- 2. To receive, consider and adopt the Report of the Council
- 3. To receive and adopt the Audited Financial Statements for the
- year ended 31 December 2023. 4. To appoint the Institute's Auditor.
- There were 216 members in attendance. Here are some updates:

### **Financial performance**

The Institute registered a 30% growth in the total income, from UGX 12.3 billion in 2022 to UGX 16 billion in 2023. The surplus was UGX 3.2 billion. Details in the <u>2023 annual report</u>.

### **ICPAU Benevolent Fund**

The Benevolent Fund is fully established as a charity organisation registered with the Ministry of Lands as a Trust. Bank account opening is now finalized. Members can write to <u>benevolent@</u> icpau.co.ug for details on how to join the Fund.

### 2019-2023 Strategic Plan

The Institute's five-year strategic season, 2019-2023 ended. The Institute demonstrated resilience, recording overall growth in total income over the period, growth in student and member numbers, increased brand strength and equity, and enhanced service delivery through accelerated automation projects. On the whole, our performance on the 2019–2023 strategic plan is ranked above 80%.

### 2024–2028 Strategic Plan

Beginning January, the Institute launched a new 5-year strategic plan, 2024-2028. In this season our renewed purpose is to empower accountants to transform communities. Our vision, mission, core values and tagline have changed, and the strategy is hinged on 5 pillars. The focus is on: increasing industry recognition and confidence in the CPA Uganda brand, introduction of new specialty ondemand certifications with open admission to other professionals, thought leadership, policy, and advocacy, research and policy analysis, strengthening collaboration between members and students, and completion of the construction of the ICPAU head office.

### Updates on the new Strategic Plan

 Specialty Courses: The tuition providers masterclass was held from 12 – 15 June 2024. There were 36 participants. The masterclass for holders of Foreign Accountancy Qualifications is scheduled for 22 – 26 July. A Business Valuation masterclass is scheduled for later this year.

- **Thought Leadership:** The Institute submitted comments on the 2024 tax and revenue bills. Members of the Institute's Taxation and Economic Policy panel contributed to the discussions on the amendment bills through opinion articles published in the media.
- **Collaborations:** The Institute has partnered with MAT ABACUS Business School in organising the 6th edition of the CFO Leadership Academy which commenced in May 2024. Other collaborations are in the pipeline.
- Regional Members Networks: Elections for executives were concluded early this year and work plans are being rolled out. There are currently 12 Regional Members Networks: 7 are active (Acholi Regional Members Network, Ankole Regional Members Network, Central Regional Members Network, Kigezi Regional Members Network, Lango Regional Members Network, Mid -Eastern Regional Members Network, & West Nile Regional Members Network).

5 are inactive (Bunyoro Regional Members Network, Busoga Regional Members Network, Southern Buganda Regional Members Network, Rwenzori Regional Members Network, & Teso/Karamoja Regional Members Network). Members were urged to volunteer and activate the remaining 5 Regional Members Networks.

- **Research:** 2 studies have been commissioned - factors affecting performance of CPA core papers; and Cost Benefit Analysis of using the IFRS for SMEs Accounting Standard.
- Institute's infrastructure: The procurement process for a contractor for the Institute's property on Plot 42 Bukoto Street is nearly complete and the project is set to commence in July 2024. The Institute continues to seek a build, operate and transfer partner for the Institute land at Lubowa, Wakiso District.

### **Accounting Standards:**

- IFRS 18 was issued in April 2024: Members are encouraged to begin early preparation for adoption.
- IFRS Sustainability Disclosure Standards: The Council will soon pronounce itself on the direction for Uganda.

• IFRS for SMEs Accounting Standard Implementation Guidelines (Revised 2024): The Council has confirmed a revision of the definition of public interest entities following engagements with key stakeholders.




# IASB Issues Narrow-Scope Amendments to Classification and Measurement Requirements for Financial Instruments


# IASB Unanimously Agrees to Finalise the Revision of the Management Commentary Practice Statement


