MONDAY, 16 SEPTEMBER 2024

The President, The Vice President, Members of Council, Members of PAEB, Staff of the Secretariat, Members of the Press, Ladies and Gentlemen.

1.0 INTRODUCTION

On behalf of the Public Accountants Examinations Board (PAEB) and on my own behalf, I wish to welcome you to the release of results for the August 2024 CPA(U) examinations diet. For the year 2024, PAEB scheduled three (3) examinations diets; that is May, August and December. We released the results for the first diet (May) in June, and today, we are releasing the results for the second diet (August). I take this opportunity to assure you, Madam President, that we are on course and as per our plans. As a reminder, August examinations are exclusively for the CPA(U) course and are conducted only at the Kampala centre.

2.0 HIGHLIGHTS ON OTHER ACTIVITIES

Before delving deeply into the details of the results, allow me to shed some light about the other activities that the Board has undertaken to date.

2.1 MASTERCLASSES

We conducted two (02) masterclasses. We started with the masterclass in pedagogy for tuition providers in June 2024. The class was attended by 32 participants and was very successful. The participants were awarded a certificate of recognition as *'Certified Tuition Provider for ICPAU Courses'*. The certificates are in their personal names.

We also conducted a masterclass for Foreign Accountancy Qualifications (FAQ) holders from Monday, 22 to Friday, 26 July 2024 here in Kampala. The class was attended by 86 We have processed all the information participants. masterclass and regarding the are now readv to communicate to the The participants. successful participants will be encouraged to apply for membership and join the Institute in developing the accountancy profession for excellence and sustainable impact.

Madam President, we are also organising a masterclass in Business Valuation in November this year. We shall report the progress in this endeavour at an appropriate time.

2.2 STUDENT ENGAGEMENT

The last time we were here, we reported about student engagement as one of the interventions to improve performance by students in our courses. I am happy to report that this is an on-going process. We have organised more engagement activities early next month—Octoberfor students preparing for the December 2024 examinations. We encourage all continuing students and new ones as well to attend.

3.0 STUDENT PERFORMANCE IN THE AUGUST 2024 EXAMINATIONS

We have noted with concern the poor performance in some subjects in these August 2024 examinations. We believe that among other things, students had not prepared well. We would therefore like to call upon candidates intending to attempt the December 2024 examinations to intensify their preparations for better outcomes.

4.0 EXAMINATIONS RESULTS

The examinations were conducted from Monday, 19 to Friday, 23 August 2024, in Kampala only as earlier mentioned. We had four (4) venues. The main venue was Uganda Manufacturers Association (UMA) Showgrounds -Lugogo, Multi-Purpose Hall. The other venues were Kyambogo University, Mengo Senior School and Uganda Institute of Information and Communications Technology for computer hands-on examinations. The Board thanks these institutions for their collaboration in this exercise.

4.1 The performance in the individual subjects was as follows:

The average pass rate was 31.0% compared to 32.9% for the August 2023 diet, implying a slight decline from the August 2023 diet.

A total of 4,401 candidates sat the August 2024 examinations, 2,438 (or 55.5%) were female and 1,963 (or 44.6%) were male. They presented a total of 6,121 scripts out of which, 3,312 (or 54.1%) were by female candidates and 2,809 (or 45.9%) were by male candidates.

In terms to registered passes, 1,896 of the total 6,121 scripts registered passes. This represents an overall pass

rate of 31.0%. A further analysis of the gender distribution shows that 1,065 of the 3,312 scripts presented by female candidates registered passes representing a pass rate of 32.2% for female candidates. Likewise, 831 of the 2,809 scripts presented by male candidates registered passes representing a pass rate of 29.6% for male candidates.

We went ahead to establish the registered passes in terms of those attempting the papers for the very first time. The results show that 800 of the 1,896 scripts that registered passes (or 42.2%) were presented by candidates attempting their papers for the first time. This demystifies the concern that CPA papers cannot be passed on the first attempt.

In terms of age, 295 (15.6%) of the passes were scored by candidates in the age bracket of 18–24 years, 750 (39.6%) by candidates in the age bracket of 25–29 years, and 551 (29.1%) by candidates in the age bracket of 30–34 years. The remaining 300 (15.8%) of the passes were scored by candidates above 34 years of age. We advise individuals planning a career in accountancy to enroll for the CPA course early in order to fairly complete the course in their youthful years.

This time round, the male candidates took up most of the top positions in the various papers. Specifically, nine (9) (42.9%) of the 21 top positions were taken by female candidates and the remaining twelve (12) (57.1%) were taken by male candidates.

With regards to the completion rate, we registered an increase of 24 compared to the August 2023 diet. Specifically, 80 students completed the CPA course compared to 64 in the August 2023 examinations. Of the 80 students who completed the course 37 (46.3%) are female and 43 (53.7%) are male.

The cumulative number of students who have completed the CPA course has now reached 5,131.

5.0 CLOSING REMARKS

PAEB congratulates all the candidates who passed their examination papers, the top candidates in the various subjects and those who have completed the CPA course.

The Board sincerely thanks the examiners, invigilators, security officials, St John Ambulance, and all the other

service providers as well as the Secretariat team for their contribution to the success of the August 2024 examinations.
