1.0 INTRODUCTION

On behalf of the Public Accountants Examinations Board (PAEB) and on my own behalf, I wish to welcome you all to the release of results for the December 2020 examinations diet.

The year 2020 was unprecedented in the history of our examinations calendar. The lockdown in March 2020 found us at the height of preparing for May 2020 examinations. We kept on postponing and hoping that the situation would normalize. We eventually ended up with only one examinations diet, in December 2020. Normally, we conduct two examinations diets for the Accounting Technicians Diploma (ATD) and Certified Tax Advisor (CTA) courses in May and November and three diets for the Certified Public Accountants (CPA) course in May, August and November.

Due to disruptions caused by COVID-19 pandemic, the number of candidates was significantly lower than normal. Nonetheless, we are grateful that we were able to pull through the whole exercise without any incidents. There was strict adherence to the COVID-19 Standard Operating Procedures (SOPs).

2.0 NEW SYLLABUSES

We were also supposed to roll out new syllabuses for ATD, CTA and CPA this year but we have now moved them to 2022. We shall launch them later this year and be examinable in 2022.

3.0 EXAMINATIONS RESULTS

The examinations were conducted for five days from 18 - 22 December, 2020 at all the examinations centres in Arua, Fort Portal, Gulu, Kampala, Mbale, Mbarara, Mbale and Nkozi.

A total of 4,453 candidates attempted the December 2020 examinations compared to 6,516 candidates who sat for the November, 2019 examinations.

As a matter of emphasis, only 4,453 candidates attempted examinations in 2020 compared to a total of 16,888 candidates in 2019.

3.1 ACCOUNTING TECHNICIANS DIPLOMA (ATD) EXAMINATIONS

151 candidates sat for the December 2020 examinations compared to 225 in November 2019.

Of the 151, 77 (51.0%) were female and 74 (49.0%) were male.

The average pass rate was 45.5% compared to 43.3% in November 2019.

In terms of gender, out of the 167 candidates who passed their papers, 75 (44.9%) were female and 92 (55.1%) were male.

Additionally, 84 (50.3%) candidates passed their papers on their first attempt.

In terms of age, 104 (62%) candidates who passed their papers were in the age bracket of 18 - 24 years and 46 (28%) in the age bracket of 25 - 29 years. The remainder 34 (10%) were above 29 years.

8 candidates completed the ATD course compared to 18 in November 2019.

Of the 8 candidates, 4 (50%) were female and 4 (50%) were male.

The cumulative total number of candidates who have completed the Accounting Technicians Diploma is 1,778.

3.2 CERTIFIED TAX ADVISOR (CTA) EXAMINATIONS

58 candidates sat for the December 2020 examinations compared to 110 who sat in November 2019. Of the 58, 14 (24.1%) were female and 44 (75.9%) were male.

In terms of gender, out of the 40 candidates who passed their papers, 10 (25%) were female and 30 (75%) were male.

In addition, out of the 40 candidates who passed their papers, 21 (52.5%) made it on first attempt.

The cumulative total number of students who have completed the CTA course is now 52.

3.3 CERTIFIED PUBLIC ACCOUNTANTS OF UGANDA (CPA) EXAMINATIONS

4,244 candidates sat for the December 2020 examinations compared to 6,181 who sat in November 2019. Of the

4,244, female candidates were 2,092 (49.3%) whereas male candidates were 2,152 (50.7%).

There was a slight improvement in average pass rate. It moved from 31.2% in November 2019 to 32.2% in December 2020.

In terms of gender, out of the 2,333 candidates who passed their papers, 1,194 (51.2%) were female while 1,139 (48.8%) were male.

Additionally, 1,325 (56.8%) made it on their first attempt. This is highly commendable.

In terms of age, 394 (16.9%) were in the age bracket of 18 - 24 years, 977 (41.9%) in the 25-28 years age bracket, 568

(24.3%) in the 30-34 years age bracket and 200 (8.6%) in the 35-39 years age bracket. The remainder 191 (8.2%) were in age bracket of 40 years and above.

We are happy to announce that 109 candidates completed the CPA course compared to 128 in November 2019.

Of the 109 candidates, 41 (37.6%) were female while 68 (62.4%) were male.

This brings the number of students who have completed the CPA course to 3,995.

4.0 **EXAMINATIONS DIETS**

In order to mitigate the disruptions of COVID-19, we plan to have four examinations diets for CPA to enable the students to recover some lost time. These diets will be in March, June, September and December 2021.

There will be two examinations diets for ATD and CTA in June and December 2021.

5.0 CLOSING REMARKS

The Public Accountants Examinations Board congratulates those candidates who passed their various examinations papers, the top candidates in the various subjects and those who have completed their courses.

We know that some students were impacted by COVID-19 in various ways and were not able to sit for examinations. Some of the candidates could not prepare adequately. We encourage them to make an effort to pass those subjects at the subsequent examinations diets.

COVID-19 is going to be around for some time until we get a vaccine. The students are encouraged to observe the SOPs and make progress on their courses.

As PAEB, we convey our sincere appreciation to the examiners, moderators, markers, security teams, invigilators, service providers and the Secretariat for their contributions to the success of the December 2020 examinations.

It is now my honour and privilege to invite you, 8th President, to release the December 2020 examinations results.
