PUBLIC ACCOUNTANTS EXAMINATIONS BOARD RELEASE OF NOVEMBER 2023 EXAMINATIONS RESULTS

WEDNESDAY, 3 JANUARY 2024

The President, Members of Council, Members of PAEB, Staff of the Secretariat, Members of the Press, Ladies and Gentlemen.

1.0 INTRODUCTION

On behalf of the Public Accountants Examinations Board (PAEB) and on my own behalf, I wish to welcome you to the release of the November 2023 examinations results. We had three examinations diets in the year 2023: May, August and November.

Before we delve into the November 2023 examinations results, PAEB has other important matters to communicate to the public.

2.0 TRANSFER OF ATD COURSE TO UBTEB

We wish to inform the public that the assessment of the Accounting Technicians Diploma (ATD) course has been transferred to the Uganda Business and Technical Examinations Board (UBTEB) with effect from 1 January 2024. UBTEB will be announcing the institutions where ATD course will be offered. This implies that ICPAU will no longer register new ATD students. However, we will continue to conduct examinations for the current students for two years (2024 and 2025. Those who will not have completed by then will be transferred to UBTEB.

UBTEB has restructured the ATD course to fit in their modular system. ICPAU will stay in close contact to ensure that the quality of the ATD products is not compromised. The ATD course will remain an accredited course by ICPAU in accordance with the Uganda Accountancy Qualifications Framework (UAQF). As such, the holders of the diploma will be exempted from Level I papers of the CPA(U) course.

3.0 PERFORMANCE AUDIT COURSE

The Institute of Certified Public Accountants of Uganda is working closely with the Office of the Auditor General (OAG) to establish a Performance Audit course. The OAG recruits auditors who learn on the job to execute performance audits. These audits require multidisciplinary capabilities to provide the needed assurances on economy, efficiency and effectiveness of programmes and various functions that can be deemed to be helpful in making government entities improve and become more efficient.

ICPAU will adopt and adapt the performance audit modular course which was rolled out in 2020 by the African Organisation of English-Speaking Supreme Audit Institutions - English Speaking (AFROSAI-E). The AFROSAI-E has a membership of 26 African countries. Its aim is to transform Supreme Audit Institutions' (SAIs) organisational capabilities for greater impact in their jurisdictions. This specialised course will be open to performance auditors and professional accountants.

4.0 CPA STUDY MATERIALS

The Institute has developed study materials for the CPA course. We are glad to inform our stakeholders especially students and tuition providers that most of them are already available at the Secretariat. The few remaining are under print and will be available in the course of this month. Detailed information will be available on ICPAU website.

5.0 NOVEMBER 2023 EXAMINATIONS

The November 2023 examinations ran from Monday 27 November — Friday 1 December 2023 at our seven (7) examinations centres of Arua, Fort Portal, Gulu, Kampala, Mbale, Mbarara and Nkozi. The courses examined were Accounting Technicians Diploma (ATD), Certified Tax Advisor (CTA) and Certified Public Accountants (CPA).

There were 6,223 candidates who sat the various papers representing an increment of 2.6% compared to the 6,067 candidates who sat the May 2023 examinations. The candidates per course were as follows:

The average pass rate was 51.2% compared 43.5% in May 2023.

The PAEB noted that ATD 12: Principles of Auditing had the lowest pass rate of 21.4%. Many candidates could not:

 (a) Point out factors to consider in establishing an overall audit strategy;

(b) Distinguish between internal audit and external check; The other challenge was about limited knowledge of other assurance engagements.

We are happy to report that 9 candidates completed the ATD course compared to 6 in May 2023.

The cumulative number of students who have completed the Accounting Technicians course has now reached 1,840.

The average pass rate has improved from 26.7% in May 2023 to 36.2% in November 2023.

The most poorly performed subjects were CTA 6: Indirect Taxes (17.1%) and CTA 10: International Taxation (6.1%). The difficult areas were:

- (a) Valuation of excisable goods;
- (b) Monthly accountability for VAT. May candidates were aggregating values for the whole year.
- (c) Inability to cite tax and case laws to support answers.

The new syllabus requires one to complete levels 1 and 2 before proceeding to Level 3. There were no candidates for this level.

The average pass rate has improved from 32.6% in May 2024 examinations to 38.5% in November 2023 examinations diet.

The most poorly performed subjects with a pass rate of 20% and below were CPA 12: Advanced Financial Reporting (15.8%), CPA 13: Public Financial Management (15.2%) and CPA 16: Audit Practice & Assurance (17.2%).

The following difficult areas were pointed out:

- (a) Preparation of journal entries and statement of changes in equity.
- (b) Preparation of adjustments in relation to prior period errors.
- (c) Application of the various standards to question requirements.
- (d) Distinction between public sector and private sector auditing.
- (e) Concentration on the discursive parts of the paper at the expense of computational areas;
- (f) Analysis and interpretation of information to aid decision-making.
- (g) Consolidation of financial statements.
- (h) Framework for Financial Reporting.
- (i) Role of the registrar of companies in the regulation of financial reporting.
- (j) Preparation of public sector financial statements
- (k) Budgeting in government entities.
- (l) Procurement and disposal of assets.
- (m) Audit evidence in relation to income and non-current assets.
- (n) Matters to be captured in the auditor's report under the 'emphasis of matter'.
- (o) Limited knowledge of International Standard on Quality Management (ISQM) 1 and 2.

There are 76 students who have completed the CPA course compared to 91 in the May 2023.

The cumulative number of students who have completed the CPA course has now reached 4,970.

PAEB has noted with concern the poor performance in some subjects. We are going to conduct a study on factors affecting performance. In the meantime, we encourage students to seek tuition from recognised tuition providers, as one of the strategies to improve their performance. A list of approved tuition providers is available on our website. We are also working on conducting a master class for tuition providers on how to teach (pedagogy).

Finally, as PAEB we extend our appreciation to the examiners, moderators, markers, security personnel, invigilators, all service providers and the Secretariat for their huge contribution to the success of the November 2023 examinations.

It is now my humble honour and privilege to invite our President, to release the November 2023 examinations results.
