1.0 INTRODUCTION

On behalf of Public Accountants Examinations Board (PAEB) and on my own behalf, I wish to welcome you to the release of results for the June 2022 examinations diet. This is the second of the planned four (4) diets of PAEB's 2022 examinations year calendar, the first one having been March, while the third and fourth being September and December respectively.

As you are aware, PAEB introduced a 4th (March) diet in 2021 to enable students recover lost time due to effects of the COVID-19 pandemic. This necessitated some adjustments in the dates of the pre-COVID-19 examinations diets; that is May to June, August to September and November to December to leave sufficient time between the diets to enable students prepare themselves.

2.0 EXAMINATIONS RESULTS

The examinations were conducted from Monday 13—Friday 17 June 2022 at the seven (7) examinations centres; that is Arua, Fort Portal, Gulu, Kampala, Mbale, Mbarara and Nkozi.

There were 4,940 candidates who attempted the June 2022 examinations compared to 4,162 in December 2021 and 4,238 in October 2021.

2.1 ACCOUNTING TECHNICIANS DIPLOMA (ATD) EXAMINATIONS RESULTS

There were 138 candidates who sat for the June 2022 examinations compared to 126 in December 2021.

The average pass rate has improved slightly from 51.0% in December 2021 to 53.2% this sitting.

In terms of gender, out of the 202 passes registered, (48.5%) were by female and 104 (51.5%) by male candidates.

Additionally, 147 (72.8%) of the passes were on first attempt of the respective papers.

In terms of age, 125 (61.9%) of the passes were scored by candidates in the age bracket of 18—24 years and 54 (26.7%) by candidates in the age bracket of 25—29 years. The remainder 23 (11.4%) were by candidates above 29 years.

6 (46.2%) of the top candidates are female and 7 (53.8%) are male.

8 students completed the ATD course compared to 10 in December 2021. Of the 8 students, 5 (62.5%) are female and 3 (37.5%) are male.

The cumulative number of students who have completed the Accounting Technicians course is now 1,808.

2.2 CERTIFIED TAX ADVISOR (CTA) EXAMINATIONS RESULTS

There were 86 candidates who sat for the June 2022 examinations compared to 62 in December 2021 and 72 in October 2021.

The average pass rate has improved significantly from 26.6% in December 2021 to 44.7% this sitting.

In terms of gender, out of the 67 passes registered, 19 (28.4%) were by female and 48 (71.6%) by male candidates.

Additionally, 48 (71.6%) of the registered passes were on first attempt of the respective papers.

In terms of age, 16 (23.9%) of the passes were scored by candidates in the age bracket of 18—24 years and 21 (31.3%) by candidates in the age bracket of 25—29 years. The rest 30 (44.8%) were by candidates above 29 years of age.

The cumulative number of students who have completed the CTA course is now 67.

2.3 CERTIFIED PUBLIC ACCOUNTANTS OF UGANDA (CPA) EXAMINATIONS RESULTS

There were 4,716 candidates who sat for the June 2022 examinations compared to 3,974 in December 2021 and 4,026 in October 2021.

The average pass rate has improved slightly from 35.5% in December 2021 to 38.5% this sitting.

In terms of gender, out of the 2,877 passes registered, 1,589 (55.2%) were by female candidates and 1,288 (44.8%) are male candidates.

Additionally, 1,911 (66.4%) of the passes were on first attempt of the various papers.

In terms of age, 436 (15.2%) of the passes were scored by candidates in the age bracket of 18—24 years and 1,259

(43.8%) by candidates in the age bracket of 25—29 years. The remaining 1,182 (41.0%) were by candidates above 29 years of age.

9 (50.0%) of the top candidates are female and 9 (50.0%) are male.

We are pleased to announce that 134 students completed the CPA course in the June 2022 sitting compared to 112 in December 2021. Of the 134 students, 68 (50.7%) are female and 66 (49.3%) are male.

The cumulative number of students who have completed the CPA course now stands at 4,589.

3.0 CLOSING REMARKS

PAEB congratulates all the candidates who passed their various examinations papers, the top candidates in the various subjects and those who have completed their course.

The Board also wishes to remind students of the remaining two diets of examinations in September and December this year. The Board advises students to make adequate preparations and not to just make appearances at examinations venues. It is adequate preparation rather than making an appearance that earns one a pass.

Finally, the Board sincerely thanks the examiners, moderators, markers, security teams, invigilators, the other service providers and the Secretariat for their enormous contribution to the success of ICPAU's examinations scheme in general and the June 2022 examinations in particular.
