1.0 INTRODUCTION

On behalf of the Public Accountants Examinations Board (PAEB), I welcome you to this function where we are releasing the June 2017 examinations results. The results were approved by PAEB on 23 June 2017.

2.0 CPA STUDY MATERIALS

When we were last here, we intimated that the Institute was in advanced stages of publishing study materials for the CPA course. I am pleased to inform you that the study materials are now available and in use. These are high quality materials. Purchase of study materials will be a condition for first time registration for an examination in a subject. This condition starts with the November 2017 examinations. We want to be sure that the students preparing for examinations, have accessed the same basic study materials.

3.0 JUNE 2017 EXAMINATIONS

The examinations were held from Monday, 29 May to Monday 5 June 2017 in seven examinations centres of Arua, Fort Portal, Gulu, Kampala, Mbale, Mbarara and Nkozi.

The examinations were for all the three courses offered by the Institute, namely:

- 1 Accounting Technicians Diploma ATD.
- Certified Tax Advisor CTA.
- 3. Certified Public Accountants of Uganda CPA(U).

3.1 ACCOUNTING TECHNICIANS DIPLOMA

There were 286 candidates who sat for the June 2017 examinations compared to 313 candidates in November 2016.

The average pass rate was 44.3% compared to 48.5% in the November 2016 sitting.

3.2 CERTIFIED TAX ADVISOR (CTA)

This was the second sitting for the CTA course since its inception in 2016. The number of candidates increased from 49 to 86 in June 2017.

The average pass rate was 42.2% compared to 57.3%. in November 2017.
