### **2025 Accountancy Service Awards**

Since their launch in 2015, the Awards have continued to evolve, updating categories each year to remain relevant and inclusive, recognising not only accountants but also other change-makers shaping the profession and our society.

#### 2025 FiRe Awards

The Institute will also hold the 15th edition of the Financial Reporting (FiRe) Awards in partnership with the Capital Markets Authority, Uganda

Securities Exchange, and Vision Group under the theme: "Sustainability Practices and Reporting in Uncertain Global Times".

#### Research

As the national Professional Accountancy Organisation, we have a strong desire to grow the body of knowledge for professional information to support evidence-based innovation and research-driven reforms, and data-based policy formulation. We are therefore introducing an annual research conference to provide a platform for accountants and other

researchers to disseminate the findings of their studies in accountancyrelated research.

The first research conference will be held on 14<sup>th</sup> November, 2025, and during this conference, we will disseminate the results of two ICPAU studies, which were commissioned in 2024. These are: 1) Factors Affecting Performance of CPA Subjects: Perspectives from Students, Graduates, Tutors and Examiners, and 2) Cost-benefit Analysis of Implementing the IFRS for SMEs Accounting Standard in Uganda. Other researchers will also have the opportunity to present their papers. Therefore, researchers, practitioners, policymakers and graduate researchers are encouraged to submit their abstracts to the Institute for the opportunity to be selected to present their papers during the first research conference.
